To nominate your outstanding fundraising volunteer or Chapter, please submit the application to the Director of Programs by **June 30**.

CRITERIA

1. Must be a member/volunteer of MADD Canada.
2. Must be nominated by a Chapter, a member or a member of the National Board.
3. Any voting member of the National Board is ineligible. (National President, President Elect and Past President are not voting members of the National Board).

Application Requirements

- Applications must be received no later than **June 30**.
- Nominations may include letters of support or newspaper articles, which further support why the nominee should receive the Fundraiser of the Year Award.

Form of Award

- A perpetual plaque containing the winners' names will be displayed at the National Office and a keeper award will be given to the winners.
- An announcement will be placed in *MADD Matters* (MADD Canada's National newsletter), and on the MADD Canada website.

Selection Process:

- The nominations will be forwarded to the National Awards Selection Committee. The committee will select the National Award winners.
